# Agenda item 1 – Improving Primary Care

## Introduction

At the last meeting of the Lewisham People’s Partnership in July 2024 we discussed Lewisham’s plans for improving primary care in Lewisham.

Long term priorities for improving primary care in Lewisham are contained in the Lewisham Five Year Forward View Delivery Plan for Primary Care (2023 to 2028). The key objective of the plan – what needs to be achieved over this five-year period - is how the model of primary care needs to change to improve the health and wellbeing of people and communities in Lewisham in line with the recommendations of the Fuller Stocktake – see *Appendix 1 for an overview of the Five Year Forward Plan and Fuller priorities alongside Lewisham’s 2024/25 strategic intentions*.

A review of what has been achieved in the first year of Lewisham’s Five Year Forward View Delivery Plan for Primary Care has highlighted that **“more focus is needed on working with the Lewisham People’s Partnership and wider local communities to support the delivery of the plan and that this should be prioritised in 2024/25 and onwards”**.

The July meeting of the Lewisham People’s Partnership agreed that meaningful, long-term engagement with patients and carers about improving primary care should be a focus for the Lewisham People’s Partnership and that people and communities in Lewisham should see their views and lived experiences demonstrably influencing decisions about improvements in primary care.

## Actions for the meeting

**We will be joined at the meeting by Ashley O’Shaughnessy, Associate Director of Community Based Care and Primary Care and Chima Olugh, Neighbourhood Development Manager, Community Based Care and Primary Care to start the process of developing, together, a work plan that will:**

- Provide the focus for engaging with the Lewisham People’s Partnership and wider local communities on the Five Year Forward View Delivery Plan
- Provide links to – and support of – other key local priorities e.g., Lewisham Neighbourhood Programme
- Support widening participation in the improving primary care engagement plans e.g., with patient participation groups, local representative groups including carers groups etc
- Support better co-ordination and sharing of that public engagement carried out by:
  - Lewisham Health and Care Partnership and
  - Voluntary, community and social enterprise organisations undertaking engagement on behalf of, or commissioned by, Lewisham Health and Care Partnership
- Support a better understanding and delivery of co-production e.g., what would we like to influence/what can we influence?
- Support the development of an outcomes framework – e.g., for feeding into the Lewisham Health and Care Partnership Strategic Board, Lewisham Primary Care Group and Lewisham Primary Care Leadership Forum - to demonstrate how the view and needs of people and communities in Lewisham influence decision making and are used in future planning and commissioning

# APPENDIX 1 - LEWISHAM HEALTH AND CARE PARTNERS FIVE YEAR FORWARD PLAN PRIORITIES, FULLER STOCKTAKE PRIORITIES LEWISHAM'S 2024/25 STRATEGIC INTENTIONS

## 1. Lewisham Five Year Forward Plan priority areas

Strengthening the integration of primary and community care	We will work together in collaboration and with the communities we serve. We want to design, plan and deliver our services with service users, patients and residents. We want team to work as close to the patient as possible and for services to be delivered through integrated multi-disciplinary approached with organisational barriers no longer getting in the way
Building stronger, healthier families and providing families with integrated, high quality, whole family support services	We will work together to join up services and to ensure all patients and carers can access the support they need when they need it. We want to support and empower parents and carers in caring for and nurturing their children and enable all children and young people to thrive
Addressing inequalities throughout Lewisham health and care system	We will contribute fully to the delivery of Lewisham's Health Inequalities and Health Equity Programme's objectives which includes improving system leadership and accountability for health equity, empowering communities, identifying and scaling up what works, and prioritising and implementing specific opportunities from the Birmingham and Lewisham African Caribbean Health Inequalities Review (BLACHIR)
Maximising our roles as Anchor Organisations, being compassionate employers and building a happier and healthier workforce	We will work together to create a range of employment opportunities for local people and create an environment that fosters wellbeing in our staff. We want to create more entry level roles and contribute to wider local economic development. We want to deploy resources more effectively and creatively to help address employment gaps. We want to improve the health and wellbeing of everyone who works for us.
Achieving financial sustainability	The ongoing financial constraints are an impetus for change and we will work together to overcomes the financial hurdles ahead. By working more closely and smartly we want to alleviate the pressure on services across the system enabling our budgets to be stretched in ways that supports effective service delivery

## 2. Fuller Stocktake priorities

The key objectives of the Fuller Stocktake is how the model of primary care needs to change to improve Lewisham populations' health and wellbeing and to deliver three key changes:

- Streamlining access to care and advice for people who get ill but only use health services infrequently providing them with much more choice about how they access care and ensuring care is always available in their communities when they need it
- Providing more proactive personalised care with support from a multi-disciplinary team of professionals to people with more complex needs including, but not limited to, those with multiple long-term conditions
- Helping people stay well for longer as part of a more ambitious and joined up approach to prevention

## 3. Lewisham Strategic Intentions for 2024/25

- **Long term conditions** including community dermatology, hypertension, musculoskeletal, respiratory, chronic kidney disease and referral process
- **Children and young people** including single point of access pilot, youth clinics, development of voluntary sector services, family hubs, paediatric care pathways, neurodiversity and asthma services
- **Older adults and urgent care** including transformation programme, wellbeing at home, home first service, admissions avoidance and NHS@Home service capacity
- **Mental health** including community crisis pathways, BAME access, early intervention and prevention services, all age autism strategy and adult mental health community service
- **Primary care and medicines** including primary care population health scheme, primary care access recovery plans, primary care health inequalities, GP practice for care homes, medicines optimisation plans, community pharmacy and atrial fibrillation detection scheme
